3. Reports

a. Las Vegas Convention Program- Peter Steinberger

Steinberger reported that convention attendance is high, second largest (second to the last Las Vegas convention). He expressed gratitude to section chairs and local arrangement chairs.

Local Arrangements Chair Michelle Kuenzi reported that there were 883 Pre-registered participants, 60 registered on site, for a total count of 943. Over 200 panels were on this year's program. She invited members to attend reception that is co-sponsored by Office of Vice-President and Provost UNLV.

b. Political Research Quarterly - Amy Mazur

The new editors assumed editorship in May 2006- new editorial team, new publisher Sage, new website, new on-line submission system. An annual report will be posted on website. The editors are looking to diversify the journal, trying to shorten turn around time –they have gone from 90 to 62 days. They are trying to not overwork reviews by limiting requests every 6 months.

c. Executive Director - Elizabeth Moulds

Most significant change this last year is the journal publication transition from the University of Utah to Sage Publications. WPSA now has two sets of legal documents – one with Sage and the other with the University of Utah. Sage has been very helpful through the transition. The managing of the membership data base is now housed in Sacramento. This will allow us more direct access to members. Next year meetings will be in San Diego- Manchester Hyatt, March 20-22, 2008 2009- Vancouver, Canada- March 18-20, 2009 Downtown Hyatt 2010-Hyatt Regency-Embarcadero- April 1-3, 2010 San Diego and San Francisco both are during Easter week.
