The 2013 meeting of the Western Political Science Association will be held at the Loews Hollywood Hotel right in the heart of Hollywood from March 28 to 30. Previous announcements identified the conference hotel as the Renaissance Hotel in Hollywood. In June, Loews Hotels & Resorts purchased the hotel. The conference hotel is located at the

WPSA Goes to the Empress in 2017

WPSA Executive Director Richard Clucas signed a contract this spring to hold the association's annual meeting in 2017 at the Fairmont Empress Hotel in Victoria, British Columbia. The Empress Hotel was designated a national historic site in 1980 because of its architectural design. Built for the Canadian Pacific Railway in the early 20th century, the Empress is a gorgeous hotel overlooking Victoria's inner harbor. The meeting will also use rooms in the connecting Victoria Conference Centre. The hotel has given the association great room rates for our members, so this will be a wonderful opportunity for members to meet in a beautiful setting.

The Association will be meeting at the Sheraton Seattle Hotel in Seattle, Washington, in 2014; Caesars Palace in Las Vegas, Nevada, in 2015; and at the Manchester Hyatt in San Diego, California, in 2016.

Association Approves Expansion of Executive Council

WPSA members overwhelmingly approved a change in the association's bylaws in March to expand the membership of the Executive Council to include the Vice-President Elect and the Editor of the Association's new journal, *Politics, Groups, and Identities*. The addition of these two members increases the size of the council from 20 to 22 members.

The final vote was 238 to 2 in favor of the expansion.

Meet the Officers



Gary M. Segura is a Professor of American Politics and Chair of Chicano/a-Latino/a Studies at Stanford University. His work focuses on issues of political representation, and on the accessibility of government and politics to America's growing Latino minority. He is also a principal in the polling firm Latino Decisions™. Among his most recent publications are "Su Casa Es Nuestra Casa: Latino Politics Research and the Development of American

Political Science," (2007) in the American Political Science Review, "Race and the Recall: Racial Polarization in the California Recall Election," (2008) in the American Journal of Political Science, Latino Lives in America: Making It Home (2010, Temple University Press), "The Future is Ours:" Minority Politics, Political Behavior, and the Multiracial Era of American Politics, (2011, Congressional Quarterly Press) and Latinos in the New Millennium: An Almanac of Opinion, Behavior, and Policy Preferences (2012, Cambridge University Press.) Segura is one of three Principal Investigators of the 2012 American National Election Studies, in 2009-10 was the President of the Midwest Political Science Association, and is Vice-President and President-elect of the Western Political Science Association. In 2010, he was elected a Fellow of the American Academy of Arts and Sciences.



Victoria A. Farrar-Myers, Ph.D. is a Full Professor and Distinguished

Teaching Professor of Political Science at the University of Texas at Arlington. She specializes in the American presidency, presidential-congressional relations, separation of powers, and campaign finance reform. Among her many publications, Dr. Farrar-Myers is the author of Scripted for Change: The Institutionalization of the American Presidency (Texas A&M Press), the co-author of Legislative Labyrinth: Congress and Campaign Finance Reform (CQ Press) and Limits and Loopholes: The Quest

for Money, Free Speech and Fair Elections (CQ Press), and the co-editor of Corruption and American Politics (Cambria Press). During 1997-1998, she served as an American Political Science Association Congressional Fellow. From 2005-2007, Dr. Farrar-Myers served as the coordinator for developing UT Arlington's Quality Enhancement Plan, a campus-wide initiative designed to enhance student learning at the University. Among her honors, she was the recipient of the 2001 University of Texas at Arlington's Chancellor's Council Award for Excellence in Teaching, the 2005 Arlington Star-Telegram Service Learning Award and the 2007 Honors College Faculty Award, and in 2011 she was inducted into UT Arlington's Academy of Distinguished Teachers.

Tyler Wilson from the University of San

Diego presented research about the use

of sports as soft power in international relations. Below is a synopsis of his research presentation.

"How do countries use sports for soft power".

Tyler Wilson University of San Diego

Joseph Nye defines soft power as "the ability to get what you want through attraction rather than coercion or payments. It arises from the attractiveness of a country's culture, political ideals and policies. When policies are seen as legitimate in the eyes of others, soft power is enhanced." Basically, soft power is the ability to achieve political ends through attraction.

Measuring soft power quantatively has not been attempted by scholars yet because it is very difficult to measure. Nonetheless, this thesis analyzed sports as a form of international soft power between nations and other international actors through a theoretical and qualitative lens. It answered the question "How do countries use sports to achieve their political agendas?"

"Sports does not merely mirror the state, but it is an extension of it." Sports has increasingly been used as a means to promote a nation's political agenda in the world. More specifically, it has been a source of soft power which helps a nation gain international appeal and legitimacy in the international public eye.

This thesis analyzed certain case studies on the nation-state level to attempt to formulate a conclusion about how countries and other international actors use sports as a means of international soft power. There have been some countries that have tried and failed to use soft power, and there have been others that have succeeded beyond what anyone thought was possible. Nonwestern countries, such as India, are starting to develop parallel sporting ventures to compete with the western world's domination of sports. Others, such as China, displayed to the world its modernity and openness with the 2008 Beijing Olympics. Britain, on the other hand, lost its international hegemony on the playing field, which was seen as a mirror of their declining hegemany as a colonial power in the early 20th century. Catalonia, an autonomus region in Spain, is trying to achieve status as an international "sport country" through its promotion of F.C. Barcelona around the world. The aformentioned cases were analyzed through Nye's theory of soft power to discover if the attempts at soft power in these countries can be deemed effective in achieving certain political agendas.

From the aforementioned analysis, it can be concluded that countries are attempting to use sports to increase their reputations abroad so they can be deemed as legitimate players in the international political realm. These countries seem to think that international sporting success and dominance is essential to achieving legitimacy and consolidation within the international political system. Countries think that achieving legitimacy and consolidating their place in international sports will help them in all other facets for achieving their non-sports political agendas.
